The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present.

Moved by Steensma, seconded by Bootsma to approve the proceedings of March 28, 2017. Motion carried by all ayes.

Moved by McDowell, seconded by Bootsma to approve the hourly rate of Communications Operator Tamara Heerde at \$21.00 per hour effective March 26, 2017. Motion carried by all ayes.

Moved by McDowell, seconded by Friedrichsen to approve the annual salary of Legal Assistant Jillian Jager at \$38,025 effective April 1, 2017. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Steensma to approve a claim to Ron Drenkow Motors, Inc. for 2 2017 Ford F-150 trucks for a total of \$56,190.00 after trade-ins. Motion carried by all ayes.
