Moved by Friedrichsen, seconded by McDowell to approve a rent assistance claim for \$300.00 to Marjean Westerman for a general assistance client. Motion carried by all ayes.

Moved by Bootsma, seconded by Friedrichsen to accept the bid of B & B Farm Drainage of \$93,734.00 for the Drainage District 5 repair project and to authorize the Chairman to sign the contract and bond. Motion carried by all ayes.
