

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

May 9, 2017

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present.

Moved by Friedrichsen, seconded by Steensma to approve the proceedings of May 2, 2017. Motion carried by all ayes.

At 9:05 a.m. a hearing on the proposed expansion of the Primrose, LLC facility located in Section 24, Dale Township was held. This expansion will be to add onto an existing swine farrowing confinement building and construct one new swine gilt confinement building at the site. Animal Unit Capacity of the confinement operation after construction: 1,207.2 animal units. (2,366 head of gestating swine, 432 head of farrowing swine and 720 head of swine gilts). There were no objections presented. The hearing was closed at 9:05 a.m.

Moved by Friedrichsen, seconded by Bootsma to authorize the Chairman to sign the County Recommendation notice to the Dept. of Natural Resources approving the expansion of the Primrose, LLC facility in Section 24, Dale Township. Motion carried by all ayes.

Moved by Bootsma, seconded by Steensma to hold a budget amendment hearing at 9:02 a.m. May 23, 2017 for the Fiscal 2017 County Budget. Motion carried by all ayes.

The County Treasurer presented the Board with the current investments. The Board reviewed them and approved.

Moved by McDowell, seconded by Bootsma to approve a drain tile crossing application of Rodney Carlson between Section 5 & 6, Union Township. Motion carried by all ayes.

O'Brien County Resolution No. 2017-14

RESOLUTION OF THE BOARD OF SUPERVISORS, O'BRIEN COUNTY, IOWA

WHEREAS, the Board of Supervisors is empowered under authority of Section 306.41 of the Code of Iowa to temporarily close sections of road by formal resolution when they deem necessary for construction, maintenance, or natural disaster,

AND WHEREAS, the Board of Supervisors, County of O'Brien, have determined that the following section of road should be temporarily closed due to road construction:

Shoulder Widening B-40: May 8, 2017 to July 1, 2017

County road B-40 (390th Street) from US Highway 59 (Silver Ave.) to M-12 (Vine Ave.) in O'Brien County, Iowa.

NOW, THEREFORE, BE IT RESOLVED, that the above described roads be closed temporarily in the manner described below.

"ROAD CLOSED" signs shall be placed on both ends of the described segments of road, and they shall remain in place until the construction is completed.
