Moved by Friedrichsen, seconded by Bootsma to approve the proceedings of October 3, 2017. Motion carried by all ayes.

Moved by Bootsma, seconded by Steensma to approve the quarterly reports for the quarter ending September 30, 2017 submitted by Allen Schucknecht, County Sheriff, Barbara Rohwer, County Auditor and Susan Smith, County Recorder. Motion carried by all ayes.

Moved by Steensma, seconded by Friedrichsen to approve the renewal of the County's Health Insurance plan with Wellmark as the third party administrator for 2018. Motion carried by all ayes.

Moved by Bootsma, seconded by McDowell to approve the hourly rate of Communications Operator Mikayla Campbell at \$24.04 effective September 26, 2017. Motion carried by all ayes.
