March 13, 2018

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present.

Moved by Bootsma, seconded by Steensma to approve the proceedings of March 6, 2018. Motion carried by all ayes.

Moved by Farnsworth, seconded by Steensma to set wages in the County Attorney's Office as follows: Jillian Jager, Legal Assistant 41,200.00 per year; Rachael Becker, Assist. Co. Attorney 39,552.00 per year; Karlann Hutchinson, Legal Assistant \$13.39 per hour and Lori Kolpin, Assist. Co. Attorney \$34,402.00 per year. These wages are effective July 1, 2018. All ayes except McDowell. Motion carried.

Moved by McDowell, seconded by Bootsma to set wages for Fiscal 2019 as follows: Recorder's Clerk \$19.50 per hour; Treasurer's Clerk \$47,019.75 per year and Communications Operator Trainer at \$24.72 per hour. These rates are effective July 1, 2018. Motion carried by all ayes.
