

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

October 9, 2018

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present.

Moved by Steensma, seconded by McDowell to approve the proceedings of October 2, 2018. Motion carried by all ayes.

Moved by Farnsworth, seconded by Bootsma to approve the hourly rate increase of Jailer Mitchell Edwards to \$24.52 per hour effective October 26, 2018. Motion carried by all ayes.

Moved by Farnsworth, seconded by McDowell to approve the tax suspension on parcel 140/0033830000 in Sheldon Corporation. Motion carried by all ayes.

Moved by Bootsma, seconded by Steensma to appoint Bolton-Menk, Inc. for engineering services relating to the repair work from the disaster damages on Drainage District No. 5. Motion carried by all ayes.

Moved by Bootsma, seconded by Steensma to approve the following drainage claims: Hudson Law Firm - \$79.25 for legal services; The Press, Inc. - \$24.06 for legal notice; Marcus News, Inc. - \$44.20 for legal notice. Motion carried by all ayes.

Moved by Steensma, seconded by McDowell to approve the quarterly reports for the quarter ending September 30, 2018 submitted by Allen Schuknecht, County Sheriff, Barbara Rohwer, County Auditor and Susan Smith, County Recorder. Motion carried by all ayes.

The drainage engineers will put together a cost estimate for damages along the right of way of the ditch and review some areas of that may still require pipe.
