Resolution of the O'Brien County Board of Supervisors

That the following resolution be adopted:

WHEREAS, by letter dated April 1, 2019, Dakota Access, LLC informed the O'Brien County Board of Supervisors that the construction of the Dakota Access Pipeline was mechanically completed on May 15, 2017;

WHEREAS, Iowa Code 479B.30 requires the O'Brien County Board of Supervisors to determine when construction of a pipeline is complete for purposes of landowners petitioning the Board of Supervisors for a compensation commission to determine damages arising from construction of the pipeline;

NOW, THEREFORE BE IT RESOLVED, that the O'Brien Board of Supervisors does hereby determine that construction of the Dakota Access Pipeline in O'Brien County has been completed for the purposes of Iowa Code 479B.30.
