The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present.

Moved by Steensma, seconded by Friedrichsen to approve the proceedings of March 23, 2021. Motion carried by all ayes.

Moved by Vanden Hull, seconded by Steensma to extend the deadline for the Families First Coronavirus Relief Act (FFCRA) leave through June 30, 2021. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Bootsma to lease the 2 acres of county farm land which was excluded from the original lease for \$275.50 per acre for the 2021 crop year to Joshua Haack and Kevin Jenness (the tenants for the crop years 2021 and 2022). Motion carried by all ayes.
