

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

March 9, 2021

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present except Sherri Bootsma.

Moved by Steensma, seconded by Friedrichsen to approve the proceedings of March 9, 2021 with a correction to the Secondary Road hour rates to exclude the rates for Part-time CDL Truck Drivers, Part-time Mowers and Summer Help. These rates will continue to be set by the County Engineer. Motion carried by all ayes.

The Board, as a Board of Canvassers canvassed the results of the City of Hartley Special Election that was held on March 2, 2021 with the following results: Question A: Shall the City of Hartley, in O'Brien County, State of Iowa, enter into a loan agreement and issue general obligation bonds in an amount not exceeding \$1,700,000 for the purpose of paying the cost, to that extent, of constructing, furnishing and equipping a municipal swimming pool? Yes – 229 votes No – 44 votes. Measure carried.

Moved by Friedrichsen, seconded by Steensma to enter into a 28E Agreement for Sharing of Law Enforcement Officers and Providing Emergency Response Assistance (HEAT Tactical Team). Motion carried by all ayes.

At 10:00 a.m. bids were received for two bridge replacement projects. Project L-B5133s5—73-71 in the 4400 block of Polk Ave. and Project L-B5128s8—73-71 in the 4300 block of Polk Ave. The following submitted bids: Prahm Construction Inc. - \$1,018,584.05; Christensen Bros., Inc. – \$1,165,433.50; Graves Construction Co. – \$1,072,380.45; Dixon Construction - \$998,801.35.

Moved by Vanden Hull, seconded by Friedrichsen to accept the bid of Dixon Construction for the bridge replacement Project L-B5133s5—73-71 in the 4400 block of Polk Ave. and Project L-B5128s8—73-71 in the 4300 block of Polk Ave for a total bid of \$998,801.35 and to authorize the Chair to sign the contract and bond. Motion carried by all ayes.
