RESOLUTION 2021-30
RESOLUTION OF THE BOARD OF SUPERVISORS, O'BRIEN COUNTY, IOWA

WHEREAS, the Board of Supervisors is empowered under authority of Section 306.41 of the Code of Iowa to temporarily close sections of road by formal resolution when they deem necessary for construction, maintenance, or natural disaster,

WHEREAS, the Board of Supervisors is empowered under authority of Section 306.41 of the Code of Iowa to temporarily close sections of road by formal resolution when they deem necessary for construction, maintenance, or natural disaster,

AND WHEREAS, the Board of Supervisors, County of O'Brien, have determined that the following section of road should be temporarily closed due to road construction:

Bridge Repair (D-11)

Local Road 300th Street Between McKinley Ave. and Monroe Ave.

NOW, THEREFORE, BE IT RESOLVED, that the above described roads be closed temporarily in the manner described below.

"ROAD CLOSED" signs shall be placed on both ends of the described segment of road, and they shall remain in place until the construction is completed.

Moved by Friedrichsen, seconded by Steensma to approve the allocation to the O'Brien County Economic Development Board for \$150,000 during Fiscal 2022. This contribution represents part of the county's 25% of the local option tax for county betterment and promotes the enhancement of opportunities for the existing county business and opportunities for new industry in the County. In addition to this, \$352,000 is budgeted for new secondary road equipment. The purchase of this equipment assists in the upkeep of the secondary road infrastructure, which also promotes county betterment. Motion carried by all ayes.

Moved by Vanden Hull, seconded by Bootsma to adopt the Fiscal 2022 Appropriations Resolution. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Vanden Hull to adopt the Interfund Transfer Resolution to transfer \$1,200,000 from the General Basic fund to the General Supplemental fund during the 2022 Fiscal year. Motion carried by all ayes.

Moved by Vanden Hull, seconded by Bootsma to adopt the Interfund Transfer Resolution to transfer \$2,704,740 from the Rural Services fund to the Secondary Road fund and \$190,569 from

the General Basic fund to the Secondary Road fund during the Fiscal 2022 year. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Steensma to adopt a Resolution approving and authorizing the appointments and annual base salaries of the deputies, assistants and clerks for the elected offices of O'Brien County for Fiscal 2022. Motion carried by all ayes.
