October 12, 2021

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present except John Steensma who was present by phone.

Moved by Friedrichsen, seconded by Vanden Hull to approve the proceedings of October 5, 2021. Motion carried by all ayes.

Moved by Vanden Hull, seconded by Bootsma to appoint County Engineer Scott Rinehart as the O'Brien County Title VI Compliance Coordinator. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Bootsma to accept the quote of Ron Drenkow Motors, Inc. for a 2022 Ford F150 Supercab pickup for \$29,397.00. Motion carried by all ayes.

Moved by Vanden Hull, seconded by Steensma to approve the quarterly reports for the quarter ending September 30, 2021 submitted by Bruce Devereaux, County Sheriff, Barbara Rohwer, County Auditor and Susan Smith, County Recorder. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Steensma to hold a budget amendment hearing for the Fiscal 2021 County Budget on November 2, 2021 at 9:20 a.m. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Steensma to accept the resignation of County Supervisor Sherri Bootsma effective October 13, 2021. Supervisor Bootsma represents District 1 of O'Brien County and has resigned due to relocation out of O'Brien County. Pursuant to Iowa Code Chapter 69, the county committee composed of the Auditor, Treasurer and Recorder shall be convened to decide if the vacancy shall be filled by appointment or by special election.
