

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

December 14, 2021

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present except Dan Friedrichsen who was present by phone.

The Board as a Board of Canvassers, canvassed the results of the Special County Election held December 7, 2021 with the following results: County Supervisor – District 1 to fill the vacancy Timothy Overmire – 117 votes; Justin McCarty – 19 votes; scattering – 2 votes. Timothy Overmire was declared elected. After administering the oath of office, Timothy Overmire was seated as the District 1 County Supervisor.

Moved by Steensma, seconded by Vanden Hull to approve the proceedings of December 7, 2021. Motion carried by all ayes.

Moved by Steensma, seconded by Overmire to authorize the Chair to sign the HAVA Cybersecurity Grant Agreement with the Iowa Secretary of State's Office in the amount of \$10,000 for the purpose of preventing, preparing for, and responding to cybersecurity threats to elections. Motion carried by all ayes.

The Board discussed sending a letter to the Iowa Utilities Board regarding the two carbon capture pipelines that are proposed for construction in O'Brien County. There have been several comments to Board members stating opposition to eminent domain being used if the projects are permitted. Discussion was tabled until next week regarding sending a position letter on the projects.
