

Ordinance No. 29
AN ORDINANCE ADOPTING COUNTY VOTING PRECINCTS
FOR O'BRIEN COUNTY, IOWA

Be it ordained by the Board of Supervisors of O'Brien County, Iowa:

Section 1. Pursuant to the Code of Iowa 49.4 and 49.7 the Board of Supervisors are establishing the following voting precincts:

Precinct 1 – Carroll and Floyd Townships including the City of Archer in Carroll & Summit Townships and excluding the City of Sheldon. Population 644.

Precinct 2 - Franklin Township including the City of Sanborn. Population 1,592.

Precinct 3 – Hartley-Lincoln-Omega Townships including the City of Hartley. Population 2,166.

Precinct 4 – Sheldon 1st Ward being that part of the Incorporated City of Sheldon lying East of the following line: Commencing at the South City limits on Washington Avenue; thence North on Washington Avenue to 6th Street; thence Northwesterly on 6th Street to 8th Avenue; thence Northeasterly on 8th Avenue to Park Street; thence East on Park Street to a straight line that extends northerly from the center line of 23rd Avenue; and thence North on that imaginary line to the North City limits. Population 1,815.

Precinct 5 – Sheldon 2nd Ward being that part of the Incorporated City of Sheldon lying North of 8th Street and East of Western Avenue, but West of the following line: Commencing at the intersection of Washington Avenue and 8th Street; thence North on Washington Avenue to 6th Street; thence Northwesterly on 6th Street to 8th Avenue; thence Northeasterly on 8th Avenue to Park Street; thence East on Park Street to a straight line that extends northerly from the center line of 23rd Avenue; and thence North on that imaginary line to the North City limits. Population 1,862.

Precinct 6 – Sheldon 3rd Ward being that part of the Incorporated City of Sheldon in O'Brien County lying South of 8th Street and West of Washington Avenue. Population 1,574.

Precinct 7 – Summit, Center, Dale and Highland Townships including the City of Primghar and excluding the portion of the City of Archer in Summit Township. Population 1,652.

Precinct 8 – Union, Baker and Caledonia Townships including the City of Paullina. Population 1,636.

Precinct 9 – Waterman, Grant and Liberty Townships including the Cities of Calumet and Sutherland. Total Population 1,241.

Section 2. Effective Date. This ordinance shall be in effect beginning January 15, 2022.
