October 11, 2022

The Board of Supervisors met as per adjournment in regular session at 9:02 a.m. with all members present.

Moved by Friedrichsen, seconded by Steensma to approve the proceedings of October 4, 2022. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Steensma to adopt a resolution to place a stop sign at the intersection of Redwood Avenue and 330<sup>th</sup> Street near the Northeast corner of Section 3 Summit Township. Ayes: Steensma Nays: McDowell, Overmire & Friedrichsen Motion defeated.

Moved by Overmire, seconded by Steensma to approve the quarterly reports for the quarter ending September 30, 2022 submitted by Bruce Devereaux, County Sheriff, Barbara Rohwer, County Auditor and Susan Smith, County Recorder. Motion carried by all ayes.
