

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

December 13, 2022

The Board of Supervisors met as per adjournment in regular session at 9:01 a.m. with all members present.

Moved by Friedrichsen, seconded by Steensma to approve the proceedings of December 6, 2022. Motion carried by all ayes.

Moved by McDowell, seconded by Overmire to review quotes for corrugated metal pipe at 10:00 a.m. February 14, 2023. Motion carried by all ayes.

Moved by McDowell, seconded by Overmire to adopt a resolution approving the following projects for payment from the American Rescue Project Act funds: O'Brien County Fair Board – Improvements to open class building and surrounding state area - \$14,982.96; County Network updates - \$138,999.21 & Upgrades for Law Enforcement Cameras - \$5,205.13. Motion carried by all ayes except Friedrichsen who abstained.

Moved by Friedrichsen, seconded by McDowell to adopt a resolution to change the status of the county attorney from full time to part time effective January 1, 2023 with an annual salary of \$77,500. Motion carried by all ayes.

Moved by Overmire, seconded by McDowell to authorize the Auditor to move forward with the acceptance of the Local Assistance and Tribal Consistency Fund Allocations that are available to eligible Revenue Sharing Counties. O'Brien County is allocated \$50,000 for Fiscal 2022 and \$50,000 for Fiscal 2023. Motion carried by all ayes.
