January 10, 2023

The Board of Supervisors met as per adjournment in regular session at 9:26 a.m. with all members present.

Moved by Vanden Hull, seconded by Steensma to approve the EMS System Development County Grant application for Fiscal 2024 for a total grant of \$165,000. Motion carried by all ayes.

Rich VanderWerff, Chair of the O'Brien County Compensation Board and Denise Steffen, Vice Chair of the O'Brien County Compensation Board gave the Board's recommendation for Fiscal 2024 as follows: County Supervisors – 3.5%; County Auditor, Recorder and Treasurer – 3.5% each; County Sheriff – 6% and County Attorney – no increase at her request. The County Supervisors took no action on the recommendation at this time. These proposed increases would begin July 1, 2023.
