

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

May 9, 2023

The Board of Supervisors met as per adjournment in regular session at 9:01 a.m. with all members present.

Moved by Steensma, seconded by Vanden Hull to approve the proceedings of May 2, 2023. Motion carried by all ayes.

Moved by Overmire, seconded by McDowell to approve the utility construction application of Osceola County Rural Water in Section 1, Floyd Township. Motion carried by all ayes.

Moved by Vanden Hull, seconded by McDowell to adopt the annual noxious weed resolution setting the date of June 12, 2023 for destruction of all noxious weeds in the County along with setting a penalty date and potential fines for non-compliance. Motion carried by all ayes.

Moved by Steensma, seconded by Overmire to set the hourly rate for the General Assistance Director at \$26.83 per hour effective July 1, 2023. Motion carried by all ayes.

Moved by Vanden Hull, seconded by McDowell to approve the wine permit application of Solsma's Punkin Patch. Motion carried by all ayes.

Moved by Steensma, seconded by McDowell to adopt a resolution approving the use of American Rescue funds in a total \$60,529.35 for the purchase of eleven copy machines for various county offices. Motion carried by all ayes.

Moved by Vanden Hull, seconded by McDowell to authorize the Chair to sign a contract with Ahlers & Cooney P.C. at a monthly fee of \$1,500.00 for legal services in regard to employment issues. There was discussion on the level of services that would be performed. Moved by Vanden Hull and McDowell to rescind the motion. Motion to rescind carried by all ayes. This will be placed on the May 16, 2023 agenda for consideration.

There was discussion regarding the public records request policy. Based on the discussion, adoption of the policy was tabled until May 16, 2023 to allow for further information.
