RESOLUTION 2023-49
RESOLUTION OF THE BOARD OF SUPERVISORS, O'BRIEN COUNTY, IOWA

WHEREAS, the Board of Supervisors is empowered under authority of Section 306.41 of the Code of Iowa to temporarily close sections of road by formal resolution when they deem necessary for construction, maintenance, or natural disaster,

AND WHEREAS, the Board of Supervisors, County of O'Brien, have determined that the following section of road should be temporarily closed due to road construction:

Bridge Placement (Replaces Low Water Crossing)

Local Road 390th St. Between Nest and Nettle Ave.

NOW, THEREFORE, BE IT RESOLVED, that the above described roads be closed temporarily in the manner described below.

"ROAD CLOSED" signs shall be placed on both ends of the described segment of road, and they shall remain in place until the construction is completed.

Moved by Steensma, seconded by Overmire to approve the utility construction application of Telcom Construction for Lumen near 4982 330th Street. Motion carried by all ayes.

Moved by Vanden Hull, seconded by Overmire to approve the quote of SPI Inc. to crush concrete at the Wallin Pit at \$6.00 per ton and a \$2,500 mobilization fee for 3,800 ton of concrete crushing. Motion carried by all ayes.

Moved by Steensma, seconded by Overmire to approve the fireworks permit of Joseph McCarty in Lincoln Township for August 17-20, 2023. Motion carried by all ayes.

Moved by Overmire, seconded by Vanden Hull to appoint Tom Konz to the O'Brien County Conservation Board for a 5-year term ending June 30, 2028. Motion carried by all ayes.

Moved by Steensma, seconded by Vanden Hull to adopt Resolution 2023-50; a resolution approving American Rescue Plan Act (ARPA) funding for \$5,000 to purchase an additional copy machine and \$47,000 for a John Deere Utility Tractor for the Courthouse/Jail Maintenance Department. Motion carried by all ayes.

The County received a construction permit application for Daniel Tewes located in Section 11, Center Township. This application is increasing the animal numbers only, with no new construction at an existing swine confinement facility. Animal unit capacity of the confinement operation after increase is 1,760 animal units (4,400 head of swine finishers). There have been no written or oral comments received on this application; the Dept. of Natural Resources will be so notified.
