The Board of Supervisors met as per adjournment in regular session at 10:00 a.m. with all members present.

Rich Vander Werff, Chair of the O'Brien County Compensation Board and Denise Steffen, Vice Chair of the O'Brien County Compensation Board gave the Board's recommendation of increases for Fiscal 2025 as follows: County Supervisors – 4%; County Auditor, Recorder and Treasurer – 4% each; County Sheriff – 9% and County Attorney – 10%. The County Supervisors took no action on the recommendation at this time. These proposed increases would begin July 1, 2024.
