

PROCEEDINGS OF O'BRIEN COUNTY SUPERVISORS

June 11, 2024

The Board of Supervisors met as per adjournment in regular session at 9:00 a.m. with all members present.

Moved by Steensma, seconded by Vanden Hull to approve the proceedings of June 4, 2024. Motion carried by all ayes.

Moved by Friedrichsen, seconded by Steensma to approve the utility construction applications of Alliant Energy for a triple phase cable under the road at 3135B Yellow Ave. Motion carried by all ayes.

Moved by Friedrichsen, seconded by McDowell to approve the fireworks applications of Joseph McCarty in Section 16, Lincoln Township. Motion carried by all ayes.

At 9:30 a.m. in accordance with the Code of Iowa, the Board canvassed the Primary Election returns for O'Brien County. A post-election audit of the Waterman-Grant-Liberty Precinct was performed on June 6, 2024 for the US House of Representative race per Iowa Code. The results were identical to the election day totals.

CERTIFICATION (CANVASS) OF PRIMARY ELECTION RESULTS**

WHEREAS, the PRIMARY ELECTION was held as prescribed by law on June 4, 2024, and;

WHEREAS, the Board of Supervisors and *ex officio* Board of Canvassers have canvassed the vote of said election in accordance with §43.49 and §50.24 of the *Code of Iowa*, now therefore;

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors and *ex officio* Board of Canvassers of O'Brien County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the PRIMARY ELECTION, held June 4, 2024, and that no obvious clerical errors were identified during the canvass.

One thousand five hundred and seventy-eight (1,578) people voted at the polls on election day.

Ninety-nine (99) absentee ballots were accepted for counting.

Zero provisional ballots were received at this election.

A total of one thousand six hundred and seventy-seven (1,677) people voted.
